SUSTAINING PAYMENT MUST BE POSTMARKED BY JANUARY 15TH, 2025

To: Derby Participant

Thank you for your nomination to the 2025 Grade 2 Heritage Place Derby. We had 47 sustaining and 6 late nominations in December, with a current account balance of \$59,700. Late nominations will be accepted through January 15th. The late nomination fee is \$2,500, which includes the January 15th, 2025 Derby payment.

Your next sustaining payment of \$500 must be postmarked on or before January 15th, 2025 to remain eligible. In addition, any payments with a January 15th, 2025 postmark that has not been received in our office within 10 days of the due date will not be accepted. I encourage you to send all payments by certified mail and have the postal employee hand cancel the envelope and your receipt at the time of mailing should any discrepancies occur. I cannot accept any payment with the postmark dated after January 15th, 2025 or received in our office after January 25th, 2025.

Reminder: If you did not send a copy of the horse registration papers with your nomination, please send a copy with your January payment.
