

SUSTAINING PAYMENT MUST BE POSTMARKED BY JANUARY 15th, 2025

Thank you for your nomination to the 2025 Grade 1 Heritage Place Futurity. We had 254 sustaining and 29 late nominations in December, with a current account balance of \$385,200. Late nominations will be accepted through January 15th, 2025. The late nomination fee is \$3,000 which includes the January 15th Futurity payment.

Your next sustaining payment of \$600 must be postmarked on or before January 15th, 2025, to remain eligible. In addition, any payments with a January 15th, 2025, postmark that has not been received in our office within 10 days of the due date will not be accepted. I encourage you to send all payments by certified mail and have the postal employee hand cancel the envelope and your receipt at the time of mailing should any discrepancies occur. I cannot accept any payment with the postmark dated after January 15th, 2025, or received in our office after January 25th, 2025.
