

## SUSTAINING PAYMENT MUST BE POSTMARKED BY JANUARY 15th, 2025

Thank you for your nomination to the 2025 Grade 2 Heritage Place Oaks. We had 57 sustaining and 12 late nominations received in December, with a current account balance of \$82,200. Late nominations will be accepted through January 15<sup>th</sup>. The late nomination fee is \$2,500, which includes the January 15<sup>th</sup>, 2025 Oaks payment.

Your next sustaining payment of \$500 must be postmarked on or before January 15<sup>th</sup>, 2025 to remain eligible. In addition, any payments with a January 15<sup>th</sup>, 2025 postmark that has not been received in our office within 10 days of the due date will not be accepted. I encourage you to send all payments by Certified Mail and have the postal employee hand cancel the envelope and your receipt at the time of mailing should any discrepancies occur. I cannot accept any payment with the postmark dated after January 15<sup>th</sup>, 2025 or received in our office after January 25<sup>th</sup>, 2025.
