Thank you for your nomination to the 2025 Grade 1 Heritage Place Futurity. We had 294 sustaining nominations and 3 late nominations in February, with a current account balance of \$777,600. Supplementary nominations at the time of entry will be accepted. The time of entry nomination is \$25,000.

Your next sustaining payment of \$600 must be postmarked on or before March 15<sup>th</sup>, 2025, to remain eligible. In addition, any payments with a March 15<sup>th</sup>, 2025, postmark that has not been received in our office within 10 days of the due date will not be accepted. I encourage you to send all payments by certified mail and have the postal employee hand cancel the envelope and your receipt at the time of mailing should any discrepancies occur. I cannot accept any payment with the postmark dated after March 15<sup>th</sup>, 2025, or received in our office after March 25<sup>th</sup>, 2025.
