SUSTAINING PAYMENT MUST BE POSTMARKED BY DECEMBER 15, 2024

Thank you for your nomination to the 2025 Grade 2 Heritage Place Oaks. We had 58 nominations received in November, with a current account balance of \$33,950. Late nominations will be accepted through December 15. The late nomination fee is \$1,500, which includes the December 15, 2024 Oaks payment.

Your next sustaining payment of \$500 needs to be postmarked on or before December 15, 2024, to remain eligible. In addition, any payments with a December 15, 2024, postmark that has not been received in our office within 10 days of the due date will not be accepted. I encourage you to send all payments by Certified Mail and have the postal employee hand cancel the envelope and your receipt at the time of mailing should any discrepancies occur. I cannot accept any payment with the postmark dated after December 15, 2024, or received in our office after December 25, 2024.

Reminder: If you did not send a copy of the horse registration papers with your nomination, please send a copy with your December 15, 2024, payment.
