Enclosed is your final payment schedule. Your last sustaining payment of \$500 needs to be postmarked on or before April 15, 2025, to remain eligible. As many of you know, the postal service has been challenging to work with, so please mail your payments early. Any payments with an April 15, 2025, postmark that have not been received in our office within 10 days of the due date will not be accepted. To prevent any discrepancies, we encourage you to send all payments by certified mail and have the postal employee hand cancel the envelope and your receipt at the time of mailing.

Be sure and contact the OQHRA at 405-881-5120 to schedule your hair testing. April 19<sup>th</sup> will be the last safe hair testing date.

Supplementary nominations will be accepted through the time of entry for \$12,500. Please contact the Remington Park racing office for time of entry information.
