



SUSTAINING PAYMENT MUST BE POSTMARKED BY JANUARY 15, 2026

To: Derby Participant

Thank you for your nomination to the 2026 Grade 2 Heritage Place Derby. We had 63 sustaining and 11 late nominations in December, with a current account balance of \$89,300. Late nominations will be accepted through January 15th. The late nomination fee is \$2,500, which includes the January 15, 2026 Derby payment.

Your next sustaining payment of \$500 needs to be postmarked on or before January 15, 2026, to remain eligible. In addition, any payments with a January 15, 2026, postmark that has not been received in our office within 10 days of the due date will not be accepted. I encourage you to send all payments by Certified Mail and have the postal employee hand cancel the envelope and your receipt at the time of mailing should any discrepancies occur. I cannot accept any payment with the postmark dated after January 15, 2026, or received in our office after January 25, 2026.

Reminder: If you did not send a copy of the horse registration papers with your nomination, please send a copy with your January 15, 2026 payment.
