



## **SUSTAINING PAYMENT MUST BE POSTMARKED BY FEBRUARY 15, 2026**

To: Oaks Participant

Thank you for your nomination to the 2026 Grade 2 Heritage Place Oaks. We had 79 sustaining and 9 late nominations in January, with a current account balance of \$160,400. Late nominations will be accepted through February 15<sup>th</sup>. The late nomination fee is \$4,500, which includes the February 15, 2026 Oaks payment.

Your next sustaining payment of \$500 needs to be postmarked on or before February 15, 2026, to remain eligible. In addition, any payments with a February 15, 2026, postmark that has not been received in our office within 10 days of the due date will not be accepted. I encourage you to send all payments by Certified Mail and have the postal employee hand cancel the envelope and your receipt at the time of mailing should any discrepancies occur. I cannot accept any payment with the postmark dated after February 15, 2026, or received in our office after February 25, 2026.

**Reminder: If you did not send a copy of the horse registration papers with your nomination, please send a copy with your February 15, 2026, payment.**
