SUSTAINING PAYMENT MUST BE POSTMARKED BY DECEMBER 15, 2025

To: Derby Participant

Thank you for your nomination to the 2026 Grade 2 Heritage Place Derby. We had 64 nominations in November, up from 48 for the same period last year, with a current account balance of \$39,700. Late nominations will be accepted through December 15. The late nomination fee is \$1,500, which includes the December 15, 2025 Derby payment.

Your next sustaining payment of \$500 needs to be postmarked on or before December 15, 2025, to remain eligible. In addition, any payments with a December 15, 2025, postmark that has not been received in our office within 10 days of the due date will not be accepted. I encourage you to send all payments by Certified Mail and have the postal employee hand cancel the envelope and your receipt at the time of mailing should any discrepancies occur. I cannot accept any payment with the postmark dated after December 15, 2025, or received in our office after December 25, 2025.

Reminder: If you did not send a copy of the horse registration papers with your nomination, please send a copy with your December 15, 2025 payment.
